(August of 2023)**

We are pleased to update to our esteemed shareholders and potential investors for our actual business performance in July 2023, as well as our business plan in August 2023 as follows:

**1. Business performance result in July of 2023**

**1.1 Commercial power production:**

- Commercial electricity output in July 2023 reached 340.61 million kWh, equivalent to 79.05% of the monthly plan.
- Electricity sales revenue in July 2023 reached 711.98 billion VND, equivalent to 83.31% of the monthly plan.
- Average gas price in July 2023 was set at 9.124196 US dollars /million BTU.

**1.2 Main activities in July of 2023:**

- Preparing works for major inspection at 100k EOH.
- Contesting for the Top 100 sustainable companies of VietNam in 2023 organized by VCCI.
- July 01<sup>st</sup>, NT2 has participated in Vietnam Competitive Generation Market (VCGM) for 11 years.
- July 19<sup>th</sup>, disclosing Financial Statement of Quarter II/2023.
- July 20<sup>th</sup>, reporting on the Corporate Governance of the first 06 months of 2023.
- July 28<sup>th</sup>, Signing ceremony for Long Term Maintenance Agreement for the next 100,000 EOH of Nhon Trach 2 Power Plant of NT2 and Siemens.
- July 28<sup>th</sup>, NT2 Board of Directors meeting.

**2. Business Plan in August, 2023**

**2.1 Commercial power production in August, 2023**

Commercial electricity output of August 2023 as per monthly business plan is 52.37 million kilowatt-hours. The end of August 14<sup>th</sup>, NT2 has generated 7.75 million kilowatt – hours, equivalent to 14.8% of its monthly business plan.

Accumulated electricity output from commercial power generation date to 14<sup>th</sup> August, 2023 was 54,249.54 million kWh.
