MONTHLY BUSINESS NOTICE (April of 2023)

1. Business performance result in March of 2023

1.1 Commercial power production:

- Commercial electricity output in March 2023 reached 414.54 million kWh, equivalent to 90.59% of the monthly plan.
- Electricity sales revenue in March 2023 reached 832.31 billion VND, equivalent to 91.38% of the monthly plan.
- Average gas price in March 2023 was set at 8.819787 US dollas /million BTU.

2.1 Commercial power production in April, 2023

Commercial electricity output of April 2023 as per monthly business plan is 444.01 million kilowatt-hours. The end of April 16th, NT2 has generated 204.99 million kilowatt – hours, equivalent to 46.17% % of its monthly business plan.

The accumulated electricity output from commercial power generation date to the end of April 16th, 2023 was 53,052.19 million kWh.
