NT2 is pleased to update to our esteemed shareholders and potential investors with our actual business performance in May, as well as our business plan in June 2016 as follow :

1. Business Performance Result in May, 2016

a. Commercial Power Production:

(NT2's 2016 business plan was based on the oil price of USD 60/barrel, which is equivalent to gas price of 5.2 USD /million BTU)

- Actual gas price in May 2016 was set at 3.87 USD/million BTU.
- May 31st, NT2 paid the principal and interest of foreign ECA loans (1st payment of 2016) with total amount of USD 11,524,153.97 and EURO 11,732,747.85 (equal to VND 577,910,485,832).

b. Main Corporate Events in May 2016 :

- May 5th : signing ceremony of the feasibility study (FS) contract for CO2 recovery and commercial liquid CO2 production from exhaust combustion gas of Nhon Trach 2 combined cycle power plant;

- May 18th, reporting on the change of outstanding voting shares due to the issuance of shares to pay dividend;
- May 19th, updating NT2 Business Registration Certificate (increasing charter capital from VND 2,739,198,430,000 to VND 2,848,760,290,000).
- May 23rd, VSD approved of depositing the additional volume: 10.956.186 shares;
- May 25th, HoSE announced the official trading date of the additional shares (June 1st, 2016);
- May 25th, contract signing ceremony for Petro Power Nhon Trach center scheme, which expected to supplement 02 combined cycle power plant with total 1,800 MW capacity;
- May 27th, signing auditing contract for fiscal year 2016;
- May 27th, sport events to celebrate “Month of Labour” 2016;
- May 30th, Forbes Vietnam assigned NT2 as one of the 50 best Vietnamese listed companies in 2016;
- May 31st, NT2 paid principal and interest of foreign ECA loans (1st payment of 2016).

2. Business Plan for June, 2016

a. Commercial Power Production in June

- Commercial Electricity Output of June 2016 as per monthly business plan is 388.55 million kWh. By June 13rd NT2 has generated 214.07 million kWh, which is equivalent to 55.1% of its monthly business plan.
